As per the report of the District Educational Officer,
Krishna at Machilipatnam and the report of the Deputy Educational
Officer, Vijayawada, the following facilities are available in
the School.

1. The management is having play ground of 1½ Acre.
2. The management provided laboratory equipment worth
of Rs. 30,000/- and they are earmarked an amount of
Rs. 25,000/- to spend on labs.
3. Provided 1361 books (542 English and 532 Telugu) to
the school library.
4. There are 320 students studying in the institution.
5. The management collecting tuition fee @ Rs. 25/- for
classes from I to V and @ Rs. 30/- from Classes VI to X.
6. The management is not collecting any donations from the
students.
7. The institution got permission by the District Educational
Officer, Krishna vide Pro.No. 19715-42/89, dt.2.11.1989
to open the school during 1989-90.
8. An amount of Rs. 39,552-20 is available in the savings
account in the bank to run the school.

9. The Management enclosed the following for information.

- a) Staff particulars who are working in the institution.
- b) Pay particulars of the Staff.
- c) The documents of the building along with the plan.
- d) Sanitary certificate obtained from the Health Supervisor.
- e) Structurally Soundness Certificate.

10. There is need to run G.B.S.S. School at Vijayawada as there are so many Central Government Employees are working.

I wish to state that the proposals in question are submitted late due to administrative delay.

I, therefore, request the Government kindly to forward the same to the Secretary to Central Board of Secondary Education, New Delhi along with 'No Objection Certificate'.
